1. What are the three most important issues for this position? (Briefly) I'm running for city council to help create a healthier, safer, and more prosperous future for Northeast Spokane and the workers and families who live here. This district is my home — I was raised here, in a working-class house, and I returned here to raise my own boys. I've seen how the neighborhood has changed and how many people have been pushed out of the middle class by rising costs for things like housing and childcare. We can do more to support working families, and when working families do better and have more money in their pockets, our entire community thrives. My top priorities are: (1) working to create a citywide affordable childcare program that allows families to access free or reduced-cost childcare so their kids get quality early learning and they can be a part of the workforce, (2) improving health and safety in our neighborhood by cleaning

up our parks, which are too often ignored in this part of the city, as well as making smart investments in services that actually address root causes like substance abuse treatment and behavioral health programs, as well as community-based approaches to safety like low-barrier youth programs, skill-development programs for young adults, and others, and (3) urgently address the housing crisis, which first and foremost means investing in building new affordable housing and allowing more housing options in our neighborhoods, as well as low-barrier supportive housing to get our unhoused neighbors indoors as quickly as possible.

- 2. What are your qualifications for the position? I was born and raised in a single-parent working family in District 1, and returned to raise my own kids here. When I moved back, I saw that our community was getting ignored while other parts of our city got time and investments. We needed an advocate, so I started attending Logan Neighborhood Council meetings because not enough of my neighbors were at the tables where decisions are made that impact us. I started organizing trash clean ups down by the river, I brought together local businesses and nonprofits to improve our neighborhoods, creating three murals in the community, and used the community engagement grant to get the city to invest in our neighborhoods, and I led the charge to get the city to improve Illinois Street and advocated for a multi-use path so it would be safe for people to walk and bike along that road and shop at local businesses. I chaired the neighborhood council for nearly five years, and I'm running for city council because I still see issues in my community that need to be addressed but are too big for a neighborhood council to solve. In my professional life I have served as a community health worker at the ZoNe working with families and the youth during the pandemic and forward.
- 3. Why is the endorsement of the Spokane Regional Labor Council important to you? The Spokane Regional Labor Council is an organization that represents thousands of working people in Spokane and the surrounding area, and your endorsement is critical to my campaign because District 1 is largely a working-class district. It's where I grew up, I know the families here, and I personally know the challenges they face. For my values, I believe workers and working families are the source of a strong economy, not the result. When working families have more money in their pockets, local businesses have more customers, make more money, and hire more people to meet the demand. Our entire community prospers. I'm prounion, will always support to protect and expand workers' right to organize, and I'd be honored to have your support.
- 4. Will you develop a process or system to give your employees an opportunity for input on issues affecting their workplace and the labor community on issues affecting working families? As it pertains to the labor community, I seek to be an ally to working families on the city council, and will always maintain open communication and seek input from labor partners in the community. In terms of my own office, I'd seek my employees' input on what processes they'd like to see in my own office, but as a start I would ensure ample avenues for employees to express their thoughts, ideas, and concerns, including regular team meetings as well as anonymous feedback mechanisms and performance reviews of me as a supervisor. I'd seek and encourage employee participation and input on not just issues impacting city employees, but all issues and policy areas that come across my desk. I want to staff my office with people who have lived experience in the communities I represent, and rely on that strong team around me to get valuable insight from perspectives and experiences that differ from my own. I also would seek to empower my team members to provide me with their policy input by ensuring they're a part of stakeholder conversations where they might have unique connections and experiences. I would also encourage my employees to actively participate in labor community organizations, initiatives, and organizing that benefits them.
- 5. What is your position on privatization of public services and the outsourcing of jobs? Privatization kills jobs. I am unequivocally opposed to privatizing public sector jobs and outsourcing jobs because it creates a race to the bottom for wages and benefits. When public jobs are privatized, private sector employers
